

Accident statistics for roads of Ukraine

During 11 months of 2018:

- 135,695 RTAs had place, this level being almost by 8% lower comparing to the previous year;
- 3,024 persons perished, including 165 children;
- 28,305 persons obtained traumas, including 3,777 children.









Strategy to increase the road traffic safety level in Ukraine for the period up to 2020

approved by the order of the Cabinet of Ministers of Ukraine (14.06.2017, N 231-p)

to fulfill the aims determined by General Assembly of the UNO in frames of the Decade of Road Traffic Safety (2011-2020)

Plan of actions concerning the Strategy aiming the increase of road traffic safety in Ukraine for the period up to 2020 [approved by the order of the Cabinet of Ministers of Ukraine (28.03.2018, N 231-p)]

Governmental Program aiming the increase of road traffic safety level in Ukraine for the period up to 2020 [approved by the order of the Cabinet of Ministers of Ukraine (25.04.2018, N 435)]

The purposes of actions being carried out during the Week of Road Traffic Safety are the following:

- to attract the attention of state organs, public organizations, mass-media, and society representatives to especially complex situation concerning the traffic safety;
- to consolidate all the efforts of state power organs, local self-government organs, transport and road keeping managers, education and scientific research institutions, insurance companies, representatives of public organizations and professional circles concerning the working-out and realization of actions aiming the road traffic safety in our country;
- to increase the responsibility of all road traffic participants as well as of competent organs for motor roads safety;
- to increase the knowledge of all citizens and especially of rising generation concerning their behavior on roads, to ensure their basic experience in pre-hospital aid necessary for RTA victims.


All-Ukrainian Action «Give Your Blood and Save a Life!»

This project is to be realized in five Ukrainian cities - Kyiv, L'viv, Kharkiv, Odessa, and Kamianets'-Podil'ski using costs provided by the European Investing Bank during 2019-2020. Its aims are decrease of RTAs quantity, decrease of traumas and mortality levels, advancement of road safety indices to mean European ones.

The Forum Participants approved and took as a basic statement the Project of the Resolution of the National Forum on the Road Traffic Safety


Its basic points are the following:

- Formation of a special committee on problems of legislative road traffic protection and its safety in the structure of the Verkhovna Rada of Ukraine;
- Formation of the leading governmental department on the road traffic protection and its safety on the level of central executive power organs,
- Delegation of plenary powers concerning local road traffic safety management;
- Elaboration and approval of long-term strategy and program on the increase of road traffic safety for the period up to 2030;
- Approval of the unified National Road Traffic Codex.

During the Week of Road Traffic Safety, workers of the Ukrtranssafety have carried out the inspection of 26,124 motor means; they have detected 3,138 cases of automobile transport-associated infringements of traffic legislation; 2,213 statements have been drawn up according to facts of infringements; 2,035 decrees have been passed concerning administrative penalties, their total sum having reached 2,161,792 UAH.

During the Week period (the 12th-18th of November 2018), special training lessons have been carried out at auto-transport institutions; the questions of pre-medical and pre-hospital aid for RTA victims having been examined; instructions on the RTA prevention have been given to drivers.
